HOW TO DISCERN THE SOURCE OF WISDOM

Proverbs 2:3-9 Yes, if you cry out for discernment, and lift up your voice for understanding, if you seek her as silver, and search for her as for hidden treasures; then you will understand the fear of the LORD, and find the knowledge of God. For the LORD gives wisdom; from His mouth come knowledge and understanding; He stores up sound wisdom for the upright; He is a shield to those who walk uprightly; He guards the paths of justice, and preserves the way of His saints. Then you will understand righteousness and justice, equity and every good path.

Christians have access to God's Wisdom to understand righteousness, justice, equity and every good path. But you have to ask yourself, why are so many Christians not finding the good path for health matters?

I believe Christians are destroyed because of lack of knowledge instead of disease. I am not stating that disease does not kill them, it is because they lack the knowledge to prevent or overcome the disease. Applying God's Wisdom to every decision helps to discern the source of the wisdom. What may look good may not be good. I want to share with you how to discern the wisdom to see if it is from above or if it is earthly, sensual and demonic.

Please do not wrongly presume that I am suggesting that you do not seek the wisdom from a doctor. That is deception and a lie to deter you from learning the truth. Christians need God's Wisdom in the arena of medical science and natural healing modalities. We can trust God to make our path straight. God has risen up doctors and scientists that have the knowledge, wisdom and understanding that come from above.

In Health matters there is a war between the Allopaths and the Naturopaths. The naturopaths use natural healing modalities and the Allopaths prefer chemicals to treat disease. The Allopaths have the upper hand because they have convinced our law makers that they have a monopoly on health knowledge. Laws have been made to prevent Naturopaths from treating cancers or claiming they have cures for cancer. Allopaths have made laws that declare anything that heals is a drug. For instance, if foods like garlic, onions, or carrots are used for healing, FDA regulations classify it is a drug.

Monopolies do not protect people, because monopolies allow greed to destroy the good for the "love of money". I believe a Christian should discern using godly wisdom, be it naturopathic or allopathic. God's Word will discern the spirit behind the wisdom. God's Word is the discerner even

of men's hearts. Nothing is hidden from God. All of creation is laid naked before His eyes.

In Allopath medicine, very little wisdom is from above because the basic theory of Allopathic medicine is restricted to evolutionary wisdom. All science is limited to the theories of evolution. Most all of the drugs are dangerous with their only purpose being to block symptoms. Drugs that have destructive side effects fail the test of godly wisdom. Drugs are also known as sorcery or pharmacia. In naturopath medicine there are many natural and safe healing modalities, but some are derived from religious theories that are rooted in idolatry. All therapies based on religious cults fail the test of godly wisdom. Even if they separate the practice from the cult, it comes with evil trade offs. God's word commands us to test every spirit. God's people should not be simple minded or naive and ignore the spirit behind a therapy. Though good may appear to come from a therapy, an evil trade off may follow. God is not mocked.

The Bible contains all wisdom and knowledge and everything we need for life and godliness. Leviticus Chapter 11 is wisdom to keep the body healthy. The Daniel diet is wisdom to keep the body healthy. God's Word is health to our flesh and strength to our bones. We are a tri-being, not just physical. The body is the temple of the Holy Spirit and we have been bought with a price and we are not our own. Should we not willingly submit our bodies as holy and a spiritual sacrifice of worship?

The American Medical Society (AMA) has dominated health care and has created a monopoly that condemns all opposing health care modalities from Chiropractic to Natural Healing. Doctors and scientists are not allowed to acknowledge God in practice or research because science is limited to evolutionary thinking. The Doctors that God has risen up cannot practice natural healing modalities for the treatment of cancers. If a person has cancer by law all doctors must refer cancer patients to the doctors who specialize in cancer treatments. If a patient does not want to use the chemo, they are basically humiliated, rejected told that they will die if they do not accept the treatment presented. Although, there are alternatives, the safe and natural healing alternatives are not allowed in cancer treatments.

If a doctor wants to practice safe and natural healing modalities and the patient wants the natural and safe modality, why are they denied this right? The dogmatic and controlling wisdom fails the test as being wisdom from above.

The wisdom of God is far greater than the wisdom of men. Christians should learn how to divide between the wisdom that is from above and the wisdom that is not from above. The fruit of the wisdom from above is found in James 3:17.

The doctors God has risen up have written many books and anyone can choose to read these books and fill their mind with knowledge and wisdom from above. My personal testimony is that after I changed my diet to pure living food and detoxified my body, I no longer have the bursitis, pain in my joints and the stabbing pain in my colon. When I learned the wisdom that these doctors teach I repented and took responsibility for my health. There are no magic herbs or drugs. God is the Cure, we reap what we sow, be it good or bad. God sets before us life and death and commands us CHOOSE LIFE.

I have no health issues and I do not fear cancer or any disease. I choose to not listen to statistics about cancer because they do not apply to those who give no place to cancer. The most remarkable positive side effect of eating a pure diet was that after two years my height had changed from 5' 4 1/4" to 5' 5 1/2". Seventeen years later I am still 5' 5 1/2".

It is the responsibility of every believer to choose whose wisdom they will trust and serve. The wisdom of the world or the wisdom that comes from above.

God is not mocked we reap what we sow. Gods Word in Psalms 1:1 says that we are BLESSED if we seek NOT the counsel of the ungodly. If you are not blessed in health matters maybe you need to repent and discern the wisdom you have been following. The following prayer may be helpful.

Prayer: Father, in the name of Jesus, please forgive me for allowing fear to blind me and keep me from hearing your voice in health matters. Lord I choose to believe your wisdom above the wisdom of the world and for trusting a godless science above your Word. You are the way, the life and the truth. Please guide me into all truth and deliver me from all deceptions. I don't know where I am deceived, but I am willing to be corrected. Lord open my spiritual eyes to know and discern your wisdom. I acknowledge you in all of my ways according to Your Word and I trust that You will make my path straight. I believe Your Word and Your Word is health to my flesh and strength to my bones. I cast down every vain imagination that exalts itself above the knowledge of God and I command sickness, disease and every infirmity spirit to leave my body. I ask that Your Word divide between my soul and my spirit and my joints and my marrow and discern the intentions of my own heart. Create in me a clean heart and a right spirit. I believe you will answer because I asked you. I believe You will tell me great and mighty things I do not know. Drive out the enemy with your word and incinerate every foreign substance in my body with the fire of Your Word. I command every cell in my body to line up with Your Word and be in balance electrically and chemically. Thank you Lord for Your healing Word and the promise of healing in Christ Jesus. In Jesus Name. Amen

The War on Cancer

Rom 8:7

For example, if the wisdom that says babies in the womb are not human life it is not wisdom from above. It is it earthly, sensual and demonic. God commands us to test every spirit. Why do so many ignore every spirit and just use carnality to test a thing? God's requires us to SUBMIT to God, resist the devil and he will flee. SUBMIT to GOD in everything; ACKNOWLEDGE God in everything and He will make your path straight. Those who walk by the SPIRIT, these are the sons of God (Romans 8).

James 3:13-18

Who is wise and understanding among you? Let him show by good conduct that his works are done in the meekness of wisdom. 14 But if you have bitter envy and self-seeking in your hearts, do not boast and lie against the truth. 15 his wisdom does not descend from above, but is earthly, sensual, demonic. 16 For where envy and self-seeking exist, confusion and every evil thing are there. 17 But the wisdom that is from above is first pure, then peaceable, gentle, willing to yield, full of mercy and good fruits, without partiality and without hypocrisy. 18 Now the fruit of righteousness is sown in peace by those who make peace.

God Commands us to seek not the counsel of the ungodly, nor sit in the seat of the scorers. Test all knowledge with the Wisdom test of God's Word. Wisdom that is from above must have the following attributes:

1. Pure
2. Peaceable
3. Gentle
4. Willing to be entreated
5. Full of mercy
6. Good fruits
7. Without hypocrisy
8. With the fruit of righteousness sown in peace

It is not wisdom from above if it cannot pass the test of God's attributes.

God's Word says that Wisdom is the Principal thing. Decisions that are not in line with the wisdom from above will lead to destruction and death. Wisdom from above leads to life.

Rom 8:5-8

For those who live according to the flesh set their minds on the things of the flesh, but those who live according to the Spirit, the things of the Spirit. 6 For to be carnally minded is death, but to be spiritually minded is life and peace. 7 Because the carnal mind is enmity against God; for it is not

subject to the law of God, nor indeed can be. 8 So then, those who are in the flesh cannot please God.

An example of carnality is the concept that medicine must destroy the body in order to effect healing, such as; the use of dangerous toxic chemo and radiation. The wisdom from above is without hypocrisy. Destroying cells is hypocrisy, which means using dangerous chemicals fail the test of wisdom from above.

Toxins are not pure, they don't bring peace to the body, and they are not gentle. The system that will not allow natural healing is not easily entreated. There is no mercy in the taking of chemo and radiation; the fruit of taking drugs is destruction and death. To say the evil is necessary to achieve healing is hypocrisy. Medical science fails the test of wisdom from above.

Do you trust wisdom that is contrary to the wisdom that is from above? Is it safe to ignore Psalms 1:1 to seek not the counsel of the ungodly? The source of the wisdom behind the drug experts who push toxic drugs, also violently suppress the natural cures. * DSHEA is the 1994 law called the Dietary Supplements Health and Education Act which says that since foods are generally regarded as safe and dietary supplements are foods, they, too, are generally regarded as safe. The FDA has the power to remove supplements which present a clear and present danger to health but does not otherwise regulate supplements. The FDA does, however, regulate health claims.
